Brief Description of Institution

The University of the Aegean (UAegean), founded in 1984, is the only island network-University in Greece, located in 6 campuses on 6 of the Aegean Sea islands (Lesvos, Chios, Samos, Rhodes, Syros, Lemnos) and is one of the largest Universities in Greece. The UAegean consists of five (six since 2017) Schools and eighteen Departments that offer 18 undergraduate (BA/BSc) and 48 postgraduate (MA, MSc & MBA) programmes in modern interdisciplinary thematic areas. Key features of the UAegean's mission are innovation, internationalization and outreach. With respect to education, these goals are achieved by placing special emphasis on the development of international educational programmes, such as joint-doctoral and post-doctoral studies, academic exchanges within the Erasmus+ programme and other educational frameworks, summer schools, open courses, and life-long learning programmes.
